

PA Fund Lupus Emergency Grant Program: Eligibility Guidelines 2025

The PA Fund Lupus Emergency Grant Program (LEGP) provides short-term, emergency financial assistance to people with lupus in the United States undergoing particularly trying times. Six grants are awarded each month to those individuals living with lupus who apply and demonstrate the most urgent financial needs. Once approved by LEGP's Review Committee, a grant is awarded up to the maximum amount of \$500.00. Applications are reviewed on a rolling basis.

Grant requests are evaluated by the review committee according to the following guidelines:

- Grants are for emergency and non-recurring personal or living expenses created by sudden loss
 of job, loss of disability benefits, awaiting public assistance, personal trauma or tragedy,
 overwhelming medical expenses, etc.
- If the number of qualifying applications submitted exceed the maximum number of grants allowed per month, the applications that demonstrate the most dire needs take priority.
- Applicants must live in the United States.
- Applicants must be age 18 or older diagnosed with lupus. Parents or guardians of children under 18 years who are diagnosed with lupus and living in the U.S. may also apply.
- Applicants cannot apply more than once in a calendar year.
- Applicants must have a household income that falls at or below 200% the Federal Poverty Level which can be calculated here.
- Applicants must offer satisfactory evidence that lupus has been medically diagnosed. This can
 be physician verification dated within the past 2 years or a recent medical visit summary showing
 your diagnosis. Handwritten notes will not be accepted.
- Applicants must identify the need and demonstrate how the grant will be used by providing one
 or more recent (within the past 3 months) outstanding bills up to or exceeding the maximum
 grant amount. Handwritten notes will not be accepted.
- Applicants must provide copies of the required supporting documents via the application or attached to an email to LEGP (legp@lupusresearch.org).
- Approved grants will be paid either directly to the applicant via Zelle or American Express e-gift card. Zelle is the preferred method of payment.
- Grants are limited to 1 per person up to a maximum of \$500 in any 12-month period. Approval of
 one grant for less than \$500 does not entitle the grant recipient to the balance in that 12-month
 period. Once the grant is awarded, the internal audit review process is closed for that recipient
 and requests for further funding will not be considered until the waiting period expires. The
 review committee will consider each application based on the applicant's situation at time of
 submission.
- Funding of a grant application does not guarantee subsequent funding.

• Examples of covered items: Temporary subsidy for rent arrears with eviction status, past due utility bills with disconnect status, emergency medical treatment
